

**RELEASE, HOLD HARMLESS,  
AND ASSUMPTION OF RISK AGREEMENT  
FOR LIVE FIRE SHOOTING**

WHEREAS, in consideration of being permitted to attend a course for instruction of firearms, for the instruction of firearms, for use of the premises, and for other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Undersigned agrees to the following:

Under Colorado law, any person who engages in sport shooting activities at a qualifying sport shooting range assumes the risk of injury or damage associated with sport shooting activities. For purposes of the foregoing, "engages in sport shooting activities" means entering and exiting a qualifying sport shooting range, preparing to shoot, waiting to shoot, shooting, or assisting another person in shooting at a qualifying sport shooting range. The term includes being a spectator at a qualifying sport shooting range and being present in the range for any reason.

Risks to the Undersigned include, without limitation, death, injury, damage, or illness to the Undersigned or damage to Undersigned's property. Examples of possible causes of harm to the Undersigned include, without limitation, accidental discharge of firearms, negligent discharge of firearms, firearm malfunctions, firing of live ammunition, and loud noise made by discharge of firearms.

Undersigned agrees to **ASSUME ALL RISKS**, whether or not described above, known or unknown, inherent or otherwise, associated with Undersigned's engagement in sport shooting activities. Additionally, Undersigned agrees **NOT TO SUE** Michael W. Bair Design, LLC, Michael W. Bair Design, LLC dba Live Fire, Michael Bair individually, the Owner of the Premises on which the sport shooting activities will, or is taking place, and all of their respective insurance carriers, representatives, attorneys, members, managers, officers, directors, and shareholders (each hereinafter a "RELEASED PARTY"). The undersigned agrees to **HOLD HARMLESS AND RELEASE any RELEASED PARTY** from ANY AND ALL liability and/or claims for injury or death to persons or damage to property arising from the Undersigned's engagement in sport shooting activities, **including those claims based on any RELEASED PARTY's alleged or actual NEGLIGENCE.**

Undersigned hereby acknowledges and agrees that Undersigned has read this instrument and understands its terms and is executing this instrument voluntarily. Undersigned furthermore hereby acknowledges and agrees that he/she has read, understands and will at all times abide by all range rules and procedures and any other rules and procedures stated by the Instructor. Undersigned acknowledges that he/she is free to not engage in sport shooting activities.

The Undersigned agrees that this instrument binds Undersigned and his/her executors, personal representatives, administrators, assignees, heirs and next of kin.
